Laura Yacek has continued to impress as she was promoted to Principal of Lamprey River Elementary School and her replacement as Assistant Principal, Dorothy Franchini, has been a welcome addition to the administrative unit. Scott Riddell has transitioned nicely into his role as Director of Student Services. In fact it is hard to believe that in just over two years this district has had seven administrative changes.

I would like to give a big shout-out to all the faculty and administrators who worked so very hard introducing Competency Based Grading back to the district and our community. This has been many years in the making and as we saw with good training and great communication to all stakeholders in our community that this has been a much smoother transition than in our previous attempt. This will give each student the individual care that they deserve and help parents understand the needs of their children. This district is also hard at work solidifying vertical and horizontal curricula that will ensure our students have the best K-12 education that we can provide. In I.T. we continue to try to improve PowerSchool. While it wasn't as smooth as we would have liked, thanks to our I.T. team most of the kinks have been worked out. I am happy to announce that report cards are now printable and much easier to decipher.

The students have participated in many events this year, from award winning artwork at the Deerfield Fair to RHS Student Council participating in the Student Council Leadership Conference in Waterville Valley. This year was our biggest year for our yearly *I Am College Bound* event. This

event gives Raymond High School students the ability to apply to many colleges in a single day with many colleges waiving application fees, saving students hundreds of dollars. The Raymond Drama Club continues to put on fantastic events like Harvey. In April the fifth graders had a spectacular week at Outdoor Classroom up in Freedom, NH, where they made the best of a very soggy situation, and the 8th graders had their annual trip to Washington D.C. In some sports news! The U12 boys soccer team won their championship this year. Anna Harmon was the 1,000 meter indoor state champion. Anya Cunningham finished in the top six at the New Hampshire Gymnastics State Meet. The Boys and Girls High School Soccer teams both made the playoffs and for the first time our High School Football team made it to the playoffs.

This year the School Board has decided to issue a warrant article to raise and appropriate up to \$50,000 to set up a committee to look into the possibilities of tuitioning out Raymond High School students. We as a School Board have not and will not issue recommendations on this issue. Over the past couple of years we have heard many people in town not support issues because they felt this is an option the town would want and should be investigated before they approve

improvements to other schools. With houses going up all over Raymond and the potential for our student population to go up to previous levels we felt that we need to have a clear and concise view on how the citizens of Raymond want to be represented.

We have continued to work with our partners in the community and I am pleased to announce that swimming at Carroll Lake Beach will be reopened in the summer of 2019. The Eco-Center continues to thrive during and after school hours. We now have classes that go out to the new pavilion and walk and study the life around Lamprey River. We will always work with our partners in the community to help increase options and offerings that the town of Raymond can be proud of.

### **Superintendent's Report**

### Tina H. McCoy, Ed.D., Superintendent of Schools

This is an exciting time for the Raymond School District, as our entire educational community works together *as one* to improve teaching and learning at all levels, and to enhance the quality of services that we provide to all students and their families. With the support of the Raymond School Board and many citizens who understand the key role our school systems plays in Raymond, we are moving forward in strategic and sustainable ways.

In the summer of 2018, the District adopted a new, five-year Strategic Plan that guides the actions of the District on an ongoing basis. The plan was collaboratively developed based on data and input from a wide range of stakeholders who care about the future of our schools and our community. The majority of our Strategic Plan focuses on curriculum, instruction and assessment; the foundation of our improvement efforts. Other aspects of the Plan address the

identified needs to increase communication, strengthen induction and support of all employees, and promote involvement with the community. In short, the Plan outlines steps that will move us assertively toward our new District Vision: <u>Uniting our school district and community to prepare students for future success; ready for anything!</u>

Raymond School District's Competency Based Education Initiative has grown immensely over the past year. As a district we have improved our academic infrastructure by adopting curriculum templates, common summative rubrics, issuing a consistent competency based report card, and completing our subject-specific competency documents with identified power standards at all levels. As part of our transition to competency based grading, all students are assessed not only on their academic progress but on the important skills that will help them succeed in life no matter what path they choose. We call these work-study practices; the attributes that employees will ultimately look for in Raymond graduates. The work-study practices are communication, creativity, collaboration, and critical thinking and problem solving as well as self-direction.

Teachers have the biggest, more direct impact on students' learning and performance. For this reason we continue to invest in our amazing teachers and other staff members so that they can continue to strive for excellence in all that they do. The professional learning that our educators have engaged in is extensive and diverse, but always targeted to areas that need to be strengthened in our schools. The Raymond School District also received \$31,536 in Title IV monies to be utilized to provide all students with access to a well-rounded education, school safety, and to improve the use of technology in order to improve the academic achievement. This new, competitive

grant will allow even more opportunities for our students and staff to learn and grow in a myriad of ways.

Each school in our community is unique, yet all three are working in concert toward consistency and alignment across the entire organization. In the area of science, there has been much collaboration among teachers in grades K-12 as they work to implement new, cross cutting academic standards that help students make connections between scientific disciplines. Twelve teachers from our District participated in a special 30 hour professional development series from the Next Generation Science Standards Exemplar Program (NGSX). The training program, which focused on the practices of developing and using models, engaging in argumentation, and constructing explanations, allowed our teachers from all three schools to engage as adult learners with science content and classroom cases as well as reflect on their own classroom practices.

All three of our schools have made strides in relation to multi-tiered systems of support. In other words, they have all worked to outline and implement systematic and coordinated ways to respond when students are not progressing sufficiently. At Lamprey River Elementary School, student data is used to make decisions about the type and amount of academic intervention that students receive, and their progress is monitored regularly. Iber Holmes Gove Middle School has taken a systemic, 'all hands on deck' approach as it uses data to group students with similar academic needs to receive forty five (45) minutes of targeted instruction per day. Student groups are adjusted regularly based on changing needs of the students. Raymond High School, leveraging a schedule that allows for personalized supports, uses student data to assign students to work with specific teachers, use computer labs, talk with guidance counselor or engage in other activities geared to individual needs or interests. The work to improve how we collectively respond - as a school system - to hasten progress for every student is ongoing across the District.

Each of our schools has also made a concerted effort to provide guidelines and supports that promote safe and secure learning environments. Thanks to generous funding from the Public School Infrastructure Fund, we now have two redesigned entryways at IHGMS that improve security at that school. We also have plans to reconfigure the main entryway at LRES to make it more secure. Our shift to a new. districtwide response to potential emergencies has been a significant effort that has impacted all aspects of School Administrative Unit 33. A.L.I.C.E. (Alert, Lockdown, Inform, Communicate & Evacuate) trainings and drills have been implemented repeatedly at all levels of the organization. We are now fully prepared to use this approach if needed.

Lamprey River Elementary School implemented a social-emotional learning class for students in an effort to proactively teach coping and interpersonal skills to our young students. Our middle school spearheaded a confidential student database that administrators across the District can use to track bullying reports over time to look for patterns that may otherwise have been overlooked. The high school implemented a character education program, called Project Wisdom, into their school day. The coordinated efforts of the District to help all students be, and *feel*, safe and secure are essential and will continue.



LRES Earth Day

There is so much more to tell about the Raymond School District! The first LRES school-wide Earth Day Celebration was a huge success! At IHGMS teachers are working hard to create quality performance assessments that will challenge students in new ways. The high school staff has been working hard to prepare for their upcoming accreditation visit from New England Association of Schools and Colleges (NEASC). Our high school is now hooked up to Town water, and all three schools can now access Town water at no cost to the District. We developed a new Technology plan, had a successful administrative review by the State Bureau of Nutrition Programs and Services, and served nearly 200 students in our community-connected after-school program. Students with disabilities are progressing, and special education program development is a priority. Our finance and human resources departments are working hard to streamline practices to get the best value possible for Raymond tax dollars. Overall, the Raymond School District is on a great path!

Our District has direction, stability and perseverance. It has great teachers, amazing students, and a community that is supportive. It has intelligent and compassionate governance. These are the ingredients needed for sustainable improvements to take root and thrive in our school system. I am truly honored to serve as the educational leader of the Raymond School District. Thank you for your interest in the Raymond School District and the children and youth of our town.

#### INDEPENDENT AUDITOR'S REPORT

To the Members of the School Board Raymond School District Raymond, New Hampshire

We have audited the accompanying financial statements of the governmental activities, each major fund, and aggregate remaining fund information of the Raymond School District as of and for the year ended June 30, 2018, and the related notes to the financial statements, which collectively comprise the School District's basic financial statements as listed in the table of contents.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

For the purposes of this paragraph, one-time expenditures shall be appropriations not likely to recur in the succeeding budget, as determined by the governing body, unless the provisions of RSA 40:14-b are adopted, of the local political subdivision.
