## KF-R Public Use of School Facilities

*Review for some recommended changes:*

***Under Scheduling Non-School Related Activities, #7, Room #101 should be changed to Room #109.***

***Under Supervision/General Conditions and Regulations, #1 Add “including chairs and tables.” This needs to be known before event.***

***Under Use of School facilities Rental Fees, fees for by Day, ½ Day, and/by the Hour should be added. Review the rates for rental fees, custodial fees, and food services fees. The fees should be mailed to Raymond School District SAU 33, not Recreation Department. Review the forms and who needs to sign off on the forms.***
