**ARTICLE 2** Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant, or as amended by vote of the first session, for the purposes set forth therein, totaling \$25,902,672 (twenty-five million, nine hundred two thousand, six hundred seventy-two dollars)? Should this article be defeated, the default budget shall be \$25,674,781 (twenty-five million, six hundred seventy-four thousand, seven hundred eighty-one dollars), which is the same as last year, with certain adjustments required by previous action of the Raymond School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.

## ARTICLES CONTINUED

**ARTICLE 5** Shall the School District vote to authorize the School Board to enter into a multi-year lease purchase agreement for the installation of up to \$1,743,064 (one million, seven hundred forty-three thousand, sixty-four dollars) of energy saving equipment and associated building and facility improvements at Raymond High School and Iber Holmes Gove Middle School, and further to raise and appropriate \$125,216 (one hundred twenty-five thousand, two hundred sixteen dollars) for annual lease payments to be partially offset by energy savings and a resulting reduction in costs? This lease agreement will contain a non-appropriation clause. Lease payments in future years will be \$125,216 (one hundred twenty-five thousand, two hundred sixteen dollars), guaranteed energy savings will be \$65,738 (sixty-five thousand, seven hundred thirty-eight dollars), so the estimated future budget impact, if this article passes is \$59,478 (fifty-nine thousand, four hundred seventy-eight dollars).

No amount to be raised by additional taxation. This warrant article is contingent upon the passing of Article 5.
