7:00 PM D. Transportation Contracts During Remote Learning _ _ _ _ Action

During this unprecedented time, we have a vested interest in helping to keep our transportation companies in business. Also, new legislation pertaining to the Care Funds Act (according to advice from NHASBO indicates, "Finally the Bill makes it clear that, by accepting funds under the CARES Act, and LEA "shall, to the greatest extent practicable, continue to pay its employees and contractors during the period of any disruptions or closures related to coronavirus" (emphasis added). Therefore, while it may be tempting for LEA's to limit costs by laying off staff or terminating contract workers, the LEA should first investigate options for keeping such personnel on, if possible."

I am asking for the Board to formally support paying transportation contracts during this time of crisis, in order to ensure that we will receive funding through the Care Funds Act and also to show our support for these important contractors. DAIL/STA is now helping with meal delivery and Durhaam has also offered to assist.
