As we are still in the middle of a nationwide bus shortage and at the tail end of the pandemic, we felt it would be best at this point in time to extend our Durham Bus Contract for one year. On page 2 of the contract, unter # 4 Term, it states that "This agreement shall be renewable for two (2) additional terms of one (1) year each, at the option and mutual written agreement of both parties". I have emailed Durham to see what an extension of 1 year would look like in regards to cost.
