At the last Board meeting, it was requested of our Business Administrator to look into whether any grant funds could be used for the PA Classroom Speakers project. Mrs. Whitmore received the following response from the NH DOE upon inquiry as to whether Infrastructure Grant funds could be used: "The recently passed State budget allocated \$1M to this fund. The PSI commission is a legislative commission and they likely will not meet until early fall. Unfortunately, I am not sure yet how the commission will grant this money. Once I know more I will let schools know."

So while there is money available, there is no guarantee at this time as to Raymond's award of funding.

Mrs. Whitmore has also inquired about using ESSER money for this project. She is awaiting response at the time of this writing.
