- 8:10 PM      D. Gile Road Property in 1830 Deed: Consideration of Interest \_\_\_\_\_ Action
- This matter is submitted for consideration by the Board at the suggestion of Joe Ilsley, Town Manager. The ownership of a very small (approximately 3,200 SF) piece of property, used for a one room schoolhouse in the past, is ambiguous. This ambiguity impedes the sale of the property, which is considered by some to be a part of a larger parcel. The Board may, at this time, consider if it claims any interest in this property or not. This matter comes before the District because the 1830 deed refers to the School District and not to the Town of Raymond.*
