BHAT Goals by June 2024

1. All schools will implement **Tier 1** to an additional 10% gain in fidelity.
2. There will be identified district and building-level teams to onboard **Restorative Practices**, with an implementation plan submitted to the school board on how to onboard RP's.
3. There will be a written procedure outlining how all three schools will utilize common language and processes for tracking and retrieving **behavior data** (ISS/OSS) in order to increase accuracy in **data based decision making**.

BH Tier 2 and 3 Services: August–December 2023

- **Seacoast Mental Health Center**
 - 9 facilitated referrals for RSD
 - RHS/IHGMS Therapist Caseload: 14 active students (4 pending)
 - School Liaison RENEW futures mapping intervention: 4 referrals
- **RHS/IHGMS Student Assistance Program Counselors** (substance use *or* at risk)
 - Referrals so far: 84 students
 - Currently providing individual/group intervention to 30 students
- **Social Workers** (mental health, family support, wraparound, remove barriers)
 - Currently providing individual/group intervention to 64 students
 - 18 are services through IEPs
- # of **SEL groups** so far: 20

BH Tier 2 and 3 Services: Top 5 Reasons for Referral

LRES:

1. Emotion Regulation/self management
2. Family Concerns
3. Social/Friendship Concerns
4. Trauma
5. Externalizing behaviors

IHGMS:

1. Social/friendship concerns
2. Emotion regulation/self management
3. Family concerns
4. Internalizing behaviors
5. Externalizing behaviors

RHS:

1. Social/Friendship Concerns
2. Internalizing behaviors
3. Family concerns
4. Emotion regulation/self management
5. Trauma

Updates

- Refining roles and involvement in team meetings: Tier 1, SIT, IEP/504, Wraparound, SEL programs, District BHAT
- Coordination/implementation of SEL groups and targeted individual counseling sessions– keeping up with referrals and being proactive while balancing crisis management!
- Behavioral Health within Special Education IEPs (34 IEPs)
- October Red Ribbon Week coordination/roll out
- Coordination of Holiday supports/resources
- Social Workers: managing McKinney Vento (homeless youth) cases
- SWIS data analyst training
- Ongoing case/topic consultation during team/department meetings

Updates

- Coordinated District Rite Aid Flu Shot Clinic (42 employees)
- Coordinated Free Raymond Lions Club Vision Screenings:
 - LRES- 160 students

- RHS nurse has trained 21 staff in CPR/First Aid certification
- RHS nurse got Certification to assess specific gravity and body composition for wrestling program per NHIAA procedures;
