Mrs. Whitmore will review the financial update for months ending November 30, 2021.

She provides the following notes regarding this month’s update:

There was a glitch in the accounting system that has not yet been corrected. The detail for the general fund expenditures shows certain lines over budget, however, there was an issue with the payroll encumbrance process. I can see that it has been corrected for December but not for November. Because we reconcile our salaries and benefits, the adjustment is seen in the Summary by Object Code.

From Mrs. Whitmore regarding estimated revenues:

The tax impact has been updated from the PowerPoint that was presented to the Budget Committee. The tax rate was being finalized at the same time the estimated revenues and tax impact were submitted. I have indicated what was presented to the School Board as well, and I tried backing into what it should have been without the final documents from the state. As you can see, we are receiving more Adequate Education money this year as opposed to what I was told originally, which does not typically change by that much. That is the reason why there is a significant change from the original presentation.
