7:20 PM D. COVID-19 Update ----- Action

COVID-19 cases in our region/community have surged significantly and have had a serious adverse impact on staffing in the District, and have impaired our current ability to provide educational services on site. This is due to a combination of factors all related to the ongoing pandemic: illness, exposures, underlying health conditions of employees (or those who reside with them). Our staffing shortages are beyond critical at this time, and I do not foresee the situation improving rapidly. We are not able to proceed with our hybrid model under the circumstances. Therefore, with regret, I recommend that the District transitions to fully remote instruction through January 18th, with students returning to on-site instruction on Tuesday, January 19, 2020. During this time, all students will be provided with direct instruction 4 days per week, with Fridays still allocated for additional remediation, reinforcement or enrichment and teacher collaboration. During this time, some students will be provided with services on-site by appointment or prior arrangement. Employees will report to work on-site unless authorized to work remotely. This recommendation is in accord with our current COVID-19 reopening plan.
