Non-Public Session:

MOTION: Beth Paris moved to enter into a non-public session under RSA 91-A:3 II (c), seconded by Melissa Sytek. Upon being individually polled Melissa Sytek, Beth Paris, Janice Arsenault, and Joe Saulnier all voted in the affirmative.

Public Input: There was no public input.

Recognition: Bill Hayes and high school students that participated in the Penguin Plunge came to speak with the Board about their experience. For the second year in a row, Raymond High School's Penguin Plunge Team has raised more money than any other high school. Freshman Delia Wright, one of the students that came to speak with the Board, raised the 2nd most amount of money of any high school student for the Special Olympics of New Hampshire. This year, the team of 130 students raised over \$47,462 to go toward Special Olympics through the February 1st Event.

Our Students/Our Schools: LRES teachers and students came to talk with the Board about the FUNdations Reading Program. Keri Watts and Jennifer Atkins described the FUNdations program. Classroom Teachers Kristen Nivison, Miranda Mahoney and Jessica Jortberg explained what the FUNdations program looks like in the classroom. Kindergarten students Jackson Frechette, Freddy EllingWood, Cora, Haley showed the Board how they practice their sound cards and tapping out words. Ms. Nivison, Ms. Mahoney and first grade students also shared a small portion of their daily FUNdations work.

Strategic Plan Update: Dr. McCoy and Mike Whaland presented the Board with their Strategic Plan Update Presentation, as found in the meeting agenda.

Preschool Design Bid Award: Marjorie Whitmore reviewed the bids received for the Preschool Design project. At this time they are recommending Cowan Goudreau Architects PLLC for the amount of \$12,250.00.

- Director of Student Behavioral Health starts on March 2, 2020
- It is currently Spirit Week at IHGMS and students are showing school spirit everyday.
