Policy EBCE has been revised and recoded to match the NHSBA sample policy, with the addition of Item I relative to public use of school facilities. As per NHSBA, this "policy was revised to combine NHSBA sample policies EBCD and EBCE (School Closings, which is now withdrawn). NHSBA combined the policies in an effort to have fewer, but more comprehensive, policies where two samples have a substantial overlap. The section on distance education was added to meet the criteria of Ed. Rule 306.22. Additionally, a section on emergency early release was added."

EBCE-R School Closings and Cancellations (Redact)

This policy has been withdrawn as an NHSBA sample policy and the information has been combined into the above policy.

EEA-R Student Transportation Services (Revise)

Edits to this policy are recommended by the Policy Committee to more accurately reflect our bus route approval process.
