Policy GCCDA establishes a procedure for employees who are not in a collective bargaining union to access a COVID leave time benefit. This policy was drafted by our attorney, and he suggests that the Board adopt this as policy because there is no collective bargaining process with wage pool employees, as opposed to MOA's which are negotiated as part of collective bargaining. This policy would only be in effect until the end of the school year.
