This proposed revised policy represents the NHSBA Model Policy in its entirety. As per the NHSBA, this revised policy incorporates the requirement that the first and second of all motions be recorded, wording to more clearly reflect the process for sealing non-public minutes, the requirement that Districts either consistently post approved meeting minutes on the District website or maintain a notice on the website as to where to find the minutes, and updated wording for clarification of other statutory requirements.

This proposed revised policy represents the NHSBA Model Policy in its entirety. As per the NHSBA, the policy was updated to “more specifically recognize the distinction between board business and public comment, and how that distinction relates to the benefit of public input at a board meeting, as well as emerging judicial decisions regarding the need for viewpoint neutrality relative to public comment rules.”

NHSBA recommends repealing this policy, as the substance of this policy has been incorporated into the NHSBA Model Policy EBCA, which is also being presented this evening for first reading.
