A Board member has requested discussion of [this policy](#). Additionally, the question was asked, "How many students at RHS wanted an honors course but did not get it this year?" According to the RHS Guidance Department there were 6 students who wanted a specific honors course but did not take the course. Of the six students, all those who ultimately declined the honors courses did so because of scheduling conflicts. For

example, Honors Precalculus conflicted with SST (2 students), Honors US History conflicted with Spanish III and Raymond Singers (2 students), Honors World Literature conflicted with Honors Biology (1 student) and one student could not fit Honors American Literature into his schedule and did not follow up with Guidance to resolve the issue. When faced with desired courses scheduled at the same time, the students chose the classes that were most important for them. (Updated 6.2.21)

There was also an inquiry about the process for Honors by Exhibition, or contracting to earn honors, while in a College and Career Ready Class. The form/process is [included here](#).

Right now there is one small group of (two) students who are in Embedded Honors and meeting with the teacher after school. This is atypical, prompted by necessity after the schedule changed on April 19th.
