## **IMDA Patriotic Exercises**

*From NHSBA:* Amendments to the policy are necessary due to the passage of HB 1300, which amends RSA 189:18. These legislative amendments require school districts to engage in certain patriotic exercises.

The amendment to the RSA includes specific reference to including discussion of the words and meaning of the Pledge of Allegiance and the Star Spangled Banner.

Section III of Division J of Public Law requires: "Each educational institution that receives Federal funds for a fiscal year shall hold an educational program on the United States Constitution on September 17 of such year for the students served by the educational institution."

#### JCA Change of School or Assignment

The additions to this policy allow the School Board to exceed the reassignment limit, if voted to do so, and clarifies that placements due to special education services do not fall under this policy.
