- Path of water from Harriman Hill, up driveway of high school, past SAU down dirt driveway to
- Lower athletic field to well.
- Pump/treatment building along dirt road.
- Easement 400' radius requiring limited use.
- Workers will remain in easement
- Town will provide water to the school district at no cost.

<u>MOTION</u>: Joseph Saulnier moved, seconded by Janice Arsenault, to approve the Declaration of Well Water System Temporary Easements and authorize the School Board Chair to sign. Voted unanimously in the affirmative.
