**ARTICLE 2** Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant, or as amended by vote of the first session, for the purposes set forth therein, totaling \$30,723,861 (thirty million, seven hundred twenty-three thousand, eight hundred sixty-one dollars)? Should this article be defeated, the default budget shall be \$31,392,336 (thirty-one million, three hundred ninety-two thousand, three hundred thirty-six dollars) which is the same as last year, with certain adjustments required by previous action of the Raymond School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. **YES** ☐ **NO** ☐

**ARTICLE 4** Shall the School District vote to raise and appropriate up to \$400,000 from surplus funds with 25% (up to \$100,000) to be placed in the existing Capital Reserve Fund for the Purpose of Educating Educationally Disabled Children (established in 2005) and 75% of that amount (up to \$300,000) to be placed in the existing Equipment, Facilities Maintenance and Replacement Capital Reserve Fund (established in 2006) and with such sum to come from June 30 fund balance available for transfer on July 1 (surplus)? No amount to be raised by additional taxation.
